Joe Harker asked about Chapter gear-rain suits, etc. and mentioned that he had a resource to look into that need for those members who might be interested. Cherie Ramsey spoke up that she had the Logos available as she had offered that option to the Chapter in the past. She added that she was currently not in a position to carry on with that option at this time. Joe offered to move forward on it. This would be especially helpful to newer members who are lacking in Chapter branded gear.
